1.Scope of MoU:

a. Role and Responsibilities of DBITI (Ist party)

b. Role and responsibilities of DBIT (2nd party)

- a) DBIT has fully equipped Mechatronics workshop and willing to made available to 1st party for conducting practical's as and when required.
